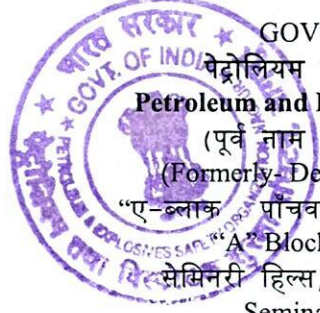


You are advised to ensure highest professional and ethical standards in certifying electrical equipments as per above standards in your laboratory.
